Florida Farm Bureau establishes Mason Smoak Memorial Scholarship

Florida Farm Bureau Federation has established a scholarship in memory of Mason G. Smoak, a Lake Placid

citrus and cattle producer who died in a plane crash near Lake Placid June 20. The Mason G. Smoak Emerging Leader Award will benefit a participant in the University of Florida/IFAS Wedgworth Leadership Institute for Agriculture and Natural Resources.

“Mason was a leader in the agriculture industry,” said John L. Hoblick, president of the Florida Farm Bureau Federation. “He was past president of Highlands County Farm Bureau and of the Florida Farm Bureau Young Farmers and Ranchers Leadership Program. He was a strong supporter of the Wedgworth Institute, of which he was an alumnus.”

The Florida Farm Bureau Federation Board of Directors will select recipients based on the recommendation of the president, in collaboration with Farm Bureau staff and the executive director of the Wedgworth Institute. The scholarship will be fully funded by Farm Bureau; individuals who wish to honor Mason Smoak are asked to donate to a separate fund, the Mason G. Smoak Memorial Fund at Heartland National Bank, 600 U.S. 27 North, Lake Placid, FL 33852.

“By establishing this scholarship, we will continue to honor Mason’s memory while supporting the Wedgworth Institute,” Hoblick said. Wedgworth fellows are mid-career professionals who participate in a two-year course of instruction and experiences, including an international tour. The Institute’s mission is to develop and refine the leadership capabilities of young leaders.

Smoak began his role in the family business of citrus and cattle following his graduation from the University of Florida. He managed the business with other family members while assuming leadership roles in the agriculture industry. In addition to his involvement in Farm Bureau, he was president of Highlands County Citrus Growers Association and chairman of the Heartland Agriculture Coalition. In

2005, Mason was awarded the Horizon Award from the College of Agriculture and Life Sciences at the University of Florida for his contributions to agriculture.

The Florida Farm Bureau Federation is the state's largest general-interest agricultural association with about 140,000 member-families statewide. Headquartered in Gainesville, it is an independent, nonprofit agricultural organization.

FRANK JOHNS RECEIVES FFVA DISTINGUISHED SERVICE AWARD

MAITLAND, Fla. (Sept. 25, 2008) – The Florida Fruit & Vegetable Association honored Frank Johns, Jr., a leader in the state's agriculture industry, with its Distinguished Service Award Sept. 23.

"For 35 years Frank has worked in the agriculture industry and epitomizes the term 'gentleman farmer,'" said FFVA Chairman Jay Taylor. "He has shared his experience and wisdom broadly in the industry through his service in many leadership positions. This man truly leads with character and integrity – in his profession and in his community."

A fourth-generation farmer, Johns briefly worked at his family's operation after attending the University of Florida. Soon thereafter he joined Tri-County Produce, growing potatoes and cabbage. In 1976 he and his wife, Polly, founded Tater Farms in the Hastings area. Formerly one of the larger producers of fresh cabbage and chipping potatoes in the area, Tater Farms shifted its focus to chipping potatoes and sod about four years ago.

Organizations benefitting from Johns' service include the Hastings Drainage District, where he served for 14 years including a stint as chairman; the National Potato Promotion Board, on which he served for six years; the Community Bible Church of St. Augustine, as a deacon and now chair of deacons; and of course, FFVA, as a member of the board of directors for 14 years and the executive committee for 11 of those years. He served with distinction as FFVA chairman from 2002-2004.

The award was announced at FFVA's 65th Annual Convention in Naples.

"I have a great deal of respect and regard for Frank," said former FFVA Chairman Hugh English. "He's a modest man of extraordinary talent who uses it unselfishly for others. He is most deserving of this award."
